

**MT. LA CROSSE RELEASE OF LIABILITY
FOR HIGH SCHOOL RACE TEAM DRY-LAND TRAINING
FOR THE 2015-2016 SKI SEASON**

**PLEASE READ CAREFULLY BEFORE SIGNING.
THIS IS A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS.**

I understand that dry-land race training on a ski hill without snow cover involves different risks, dangers, and hazards than those common in skiing and snowboarding. Risks include, but are not limited to, rocks, stumps, branches, slippery and uneven ground, including ruts and holes, tall grass, snowmaking and grooming equipment and operations, slipping, stumbling, tripping, and collisions with other persons and other natural and man-made hazards or obstacles.

In consideration of the use of Mt. La Crosse and its facilities for dry-land training, **I, on behalf of myself and/or my child, RELEASE AND FULLY DISCHARGE Mt. La Crosse, Inc., its owners, officers, shareholders, agents, and employees (collectively the "MT. LA CROSSE RELEASEES") from any liability resulting from any personal injury to me/my child, including death, which is caused by the NEGLIGENT ACT OR OMISSION of any MT. LA CROSSE RELEASEE in the maintenance of the conditions on or about the premises.**

I accept full responsibility for any injuries or damages to me/my child which may result from my/my child's participation in the dry-land training, and I hereby **HOLD HARMLESS** the MT. LA CROSSE RELEASEES for any injury sustained by me/my child, including death, while participating in the dry-land training. I agree not to bring any action or lawsuit against the MT. LA CROSSE RELEASEES for any injury caused by the NEGLIGENT ACT OR OMISSION of any MT. LA CROSSE RELEASEE.

In accordance with Wisconsin law, nothing in this Release should be construed as releasing, discharging, or waiving any claims I/my child may have for reckless or intentional acts on the part of any MT. LA CROSSE RELEASEE.

I understand that for a fee of \$25.00 in addition to the normal fee, Mt. La Crosse offers an optional Dry Land Training Agreement that does not require me to sign a release of liability. In signing this Release of Liability, I acknowledge I am aware of this option offered by Mt. La Crosse and hereby waive my right to purchase the same.

In the event I am signing as a parent of a minor, I represent I have full authority to do so, realizing this Release is binding upon the minor as well as myself.

I HAVE CAREFULLY READ THIS DRY-LAND TRAINING RELEASE OF LIABILITY AND UNDERSTAND ITS CONTENTS. I AM AWARE BY SIGNING THIS RELEASE OF LIABILITY, I AM WAIVING CERTAIN LEGAL RIGHTS FOR MYSELF/MY CHILD, INCLUDING THE RIGHT TO SUE MT. LA CROSSE, INC., ITS OWNERS, OFFICERS, SHAREHOLDERS, AGENTS, OR EMPLOYEES FOR ACTS OF NEGLIGENCE.
