

# MT. LA CROSSE LEAGUE RACING RELEASE OF LIABILITY FOR 2021-2022

**PLEASE READ CAREFULLY BEFORE SIGNING.  
THIS IS A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS.**

## **A. ACKNOWLEDGMENT OF RISKS AND RESPONSIBILITIES.**

I understand and agree that skiing, ski racing and practicing for ski racing competitions while participating in the Mt. La Crosse, Inc. League Racing involves risks, dangers, and hazards that may cause serious personal injury or death and that injuries are a common and ordinary occurrence in the sport and in racing and in race practices. Risks include, but are not limited to, falls, changes in terrain, weather, and snow surfaces, ice, bare spots, debris, fences, trees, slalom poles, ruts, posts, signs, lift equipment and towers, snowmaking, grooming, and snowmobile equipment and operations, padded and non-padded barriers and obstacles, collisions with other persons and other natural and man-made hazards, and improperly adjusted or malfunctioning equipment. I freely accept and assume the risks associated with skiing, ski racing, and practicing for ski races at the Mt. La Crosse League Races.

I represent I possess the necessary skills and physical ability to compete in ski racing and racing practices in such a manner that I will not endanger myself, other competitors, spectators or other persons. I understand that as a skier I am bound by certain Wisconsin state laws and the Skier Responsibility Code. I understand it is my responsibility to inspect the courses prior to competitions and practices to help avoid falls and collisions and to help avoid injury to myself and others. I understand I am responsible for inspection and maintenance of my equipment.

## **B. RELEASE OF LIABILITY.**

In consideration of the permission to ski and participate in the Mt. La Crosse, Inc. League Racing and its races and practices and to use Mt. La Crosse, Inc.'s facilities, **I HEREBY RELEASE AND FULLY DISCHARGE Mt. La Crosse, Inc., its owners, officers, shareholders, instructors, agents or employees (collectively the "MT. LA CROSSE RELEASEES") from any liability with respect to:**

- the preparation, organization, coordination, judging, operation, or supervision of the ski races or practices;
- the preparation, design, layout, location, construction, inspection, maintenance, or repair of all ski race and practice race courses;
- instructions given or not given to me concerning the ski racing or ski race practices or the race or practice courses;
- the condition of the snow surface, presence of snowmaking, grooming, and snowmobile equipment and operations, the operation of chairlifts, and lift loading, riding, and unloading operations;
- padding or non-padding of natural and man-made obstacles and hazards;
- posting or failure to post warnings, signs, fences, or other cautions or barriers, and the construction of or non-construction of fences and other barriers, including the selection of the construction materials; and
- **the training and equipment necessary to safely unload a skier in the event the skier is slipping out of or hanging from a chairlift.**

In accordance with Wisconsin law, nothing in this Release of Liability should be construed as releasing, discharging or waiving any claims I may have for reckless or intentional acts on the part of any MT. LA CROSSE RELEASEE.

I understand that, for a fee of \$100.00 in addition to the normal race camp fees, Mt. La Crosse, Inc. offers an optional League Racing Agreement that does not require me to sign a release of liability. In signing this Release of Liability, I acknowledge I am aware of this option offered by Mt. La Crosse and hereby waive my right to purchase the same.

**I HAVE CAREFULLY READ THIS LEAGUE RACING RELEASE OF LIABILITY FOR THE 2021-2022 SKI SEASON AND UNDERSTAND ITS CONTENTS. I AM AWARE THAT BY SIGNING THIS LEAGUE RACING RELEASE OF LIABILITY, I AM WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE MT. LA CROSSE, INC., ITS OWNERS, OFFICERS, SHAREHOLDERS, INSTRUCTORS, AGENTS OR EMPLOYEES FOR ANY OF THE ABOVE DESCRIBED NEGLIGENT ACTS OR OMISSIONS OF ANY MT. LA CROSSE RELEASEE.**
