

**RELEASE OF LIABILITY:**

I understand that there are risks, dangers, and hazards associated with the sport of skiing in its various forms, including snowboarding, that may cause serious personal injury or death and that injuries are a common and ordinary occurrence in this sport and in this Ski and Ride School. In consideration of my participation in classes, instruction and/or lessons by the Ski and Ride School and use of Mt. La Crosse facilities, **I HEREBY RELEASE AND FULLY DISCHARGE Mt. La Crosse, Inc, its owners, officers, shareholders, instructors, agents, and employees (collectively the "MT. LA CROSSE RELEASEES") from any liability resulting from any personal injury which is caused by any NEGLIGENT ACT OR OMISSION of any MT. LA CROSSE RELEASEE with respect to:**

- the preparation, organization, coordination, operation or supervision of the Mt. La Crosse Ski and Ride School;
- classes, instructions or lessons given or not given to me;
- the selection of the ski run for the lesson(s);
- the design, location, construction, inspection, and maintenance of hips, **spines and** jumps, including their height, their start location, and the angle and length of their approaches, **and the angle and length of their** take-off ramps and landing areas;
- the design, location, construction, inspection, and maintenance of all other terrain features, including rollers, rails, boxes, wall rides, and pole jams, together with the angle and length of their approaches, take-off ramps and landing areas and head wall, etc.;
- grooming, snowmaking, and snowmobile operations and equipment, the operation of chairlifts and conveyor and handle tows, and chairlift and conveyor and tow loading, riding, and unloading operations for the Mt. La Crosse Ski and Ride School, including the presence or absence of restraint bars on the chairs of the chairlift;
- the padding or non-padding of natural and man-made obstacles and hazards on, adjacent to, or off the skiable terrain;
- the posting or failure to post warnings and signs, and the construction of or non-construction of fences or other barriers, including the selection of the construction materials;
- the classification and labeling of trails, ski runs, and terrain features;
- the presence of snowmaking pipes, hydrants, guns, wands, and other snowmaking equipment, light poles, rocks, and trees on and adjacent to the ski runs; and
- **the training and equipment necessary to safely unload a skier in the event the skier is slipping out of or hanging from a chairlift.**

In accordance with Wisconsin law, nothing in this Release of Liability should be construed as releasing, discharging, or waiving any claims I may have for reckless or intentional acts on the part of any MT. LA CROSSE RELEASEE.

I understand that for a fee of \$25.00 in addition to the normal Ski and Ride School fee, Mt. La Crosse offers a Ski and Ride School agreement that does not require me to sign a release of liability. In signing this Ski and Ride School Release of Liability, I acknowledge I am aware of this option offered by Mt. La Crosse and hereby waive my right to purchase the same.

**I HAVE CAREFULLY READ THIS SKI AND RIDE SCHOOL RELEASE OF LIABILITY AND UNDERSTAND ITS CONTENTS. I AM AWARE THAT BY SIGNING THIS SKI AND RIDE SCHOOL RELEASE OF LIABILITY, I AM WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE MT. LA CROSSE, INC, ITS OWNERS, OFFICERS, SHAREHOLDERS, INSTRUCTORS, AGENTS OR EMPLOYEES FOR ANY OF THE ABOVE-DESCRIBED NEGLIGENT ACTS OR OMISSIONS OF ANY MT. LA CROSSE RELEASEE.**
